After signing in at the weighbridge office I proceeded onto site unaccompanied. Walked up to the current tipping area. There were lots of piles of soils deposited on the ground. Photo were taken during the site inspection.

No issues with any of the piles of soil were observed. No signs of contamination in the freshly deposited piles. As a result there were no issues observed on site.

### Waste Returns

A review of the 2017 waste returns was carried out. The following totals were observed:

Jan to March 2017 - 25897.55 tonnes

April to June 2017 - 14148.29 tonnes

July to Sept 2017 - 17640.75 tonnes

Oct to Dec 2017 - 20892.3 tonnes

The total quantity of waste accepted during 2017 is 78578.89 tonnes. There are no issues with this accepted quantity of waste. However, I just want to remind you that the maximum annual throughput at the site is limited to 80,000 tonnes per year. (the permit defines 'year' as calendar year ending 31 December).
