A review of the waste returns submissions for permit number EPR-FB3897TV has been completed. Unfortunately we have not received the waste returns for quarter 1 2014, quarters 1, 2 & 4 2015 and quarters 1, 2, 3, & 4 2016. This is a breach of condition 4.2.2 of your permit. You are required to submit within one month of the end of each quarter the waste returns for the previous quarter even if they are nil. As result of this breach of permit condition both a CCS score and a site warning have been applied.

You are also required to ensure that a management system is implemented by the 15th May 2017 to ensure this breach does not occur again.
