While driving from Onllwyn to Glynneath I passed the site on 08/07/2015. I noticed a significant amount of mud and debris on the road (A4019 - Heol Y Glyn). This was clearly linked to the entrance to the Cuddy site (900085) and was evidenced by the tyre tracks coming away from the site, spreading it down the road. This carryover of waste has in turn caused minor pollution of Nant Gwyddyl a tributary of the Afon Nedd via surface water drainage of the A4019 (Heol Y Glyn). The problem appears to have been caused by a lack of pollution prevention at the entrance to the site and a failure to identify this as a site management issue under the EMS (Environmental Management System).

Not scored under F5 Deposits on the road - Standard rules permit does not contain conditions relating to this particular issue.

NRW recommend that you liaise with regulatory officers and propose a scheme to combat this issue as a priority. Also that you create and implement an EMS to manage issues such as this and also the day to day running of the site. You may wish to do this within your organisation, or you may wish to employ an environmental consultant to do so. However in order to be in compliance with your permit, you must have an EMS.

We will be happy to liaise with you on both issues as they progress.
