On review it has been noted that the site has accepted waste with EWC codes including: 16 06 01, 16 05 04, 17 05 04, 15 01 02, 15 01 05 and 20 01 34. These codes are not listed as acceptable waste types in Appendix A of Schedule 2 of the permit. Wastes with the above EWC codes should not be accepted at the site. However, if you wish to continue to accept wastes with these EWC codes they can be added to the permit by way of a variation.
