1 What waste operations are you applying for?

Table 1a – Waste operations which do not form part of an installation

Newport Liquid Waste Treatment Site will accept liquid organic waste that is biodegradable. The waste will be accepted into a storage tank, with a mixer and will be blended. The liquid waste will be discharged under a trade effluent agreement to Nash WwTW. Final treatment of the waste will be through biological treatment via Nash WwTW.
