This was a routine site inspection carried out by Rachel Twiss. The weather was dry and fine at the time of the visit. Rob Gardiner was present on site and accompanied me throughout the inspection. I signed in the site diary as a record of the inspection.

Observations:

The entrance was clear of any dust or mud. The site was busy at the time but all waste types, storage, segregation and general operations on site looked to be managed well and in excellent order. A number of skips were situated outside of the permitted area but Rob explained that a large container had just gone off site and therefore skips had been moved briefly to enable the container to be removed. I was assured that the skips would be back within the permitted area that afternoon.

No breaches were recorded during this inspection.
