On the 12th May 2016 Chris Thomas and David Ellar of NRW visited the site.

I understand that there are two permits on this site the Waste Transfer station and the as yet non-operational End of Life Vehicle site.

Overall the WTS station appeared clean and tidy. The majority of the skips were stored as per your permit and EMS on the concrete pad with sealed drainage. Some empty skips were stored on hardstanding. Please ensure that any skips with waste in are stored on the concrete pad. I note from your EMS that the concreted area is to be roofed. I strongly advise that this is done as a priority. This will reduce the amount of leachate that is likely to occur and therefore reduce costs and risk.

Please can you update the site signage so that it reflects the fact that it is now regulated by NRW and update the contact numbers to 0800 80 70 60 and 0300 065 3000.

The WAMITAB Continuing Competence Certificate is now out of date 15/04/2016. Can you forward on your up to date certificate for the Waste Transfer station by the 27th June 2016.
