Complaints have been received regarding noise issues caused by new trommel and picking line use. At the time of inspection the machinery was not in use so an assessment could not be carried out. Mark Davies provided a copy of a noise assessment as carried out by Tony Crotty of green triangle.



Updates must be made to the Environment Management System, maintenance records and staff training logs to reflect the changes in procedures due to the introduction of new plant and equipment.

The yard area is quite untidy. There is no clear segregation between some piles of waste. Please ensure that housekeeping is priority for all members of staff.



Interceptor is emptied and cleaned annually. Last done February 2014. It may be advisable to have the structural integrity of the interceptor checked as this has not been done since it was installed a considerable time ago. Please ensure that all drainage channels are well maintained and kept clear of blockages.



Aggregate production on site was discussed. Material that goes as non-waste generally goes in small quantities to operators such as McCarthys, Crynant Plant and other small builders. Spoke with Tony Crotty on telephone who explained that Davies Skips has been working to WRAP protocol since 2007. He explained that they only make general fill so there is not a requirement for testing apart from visual inspection in line with PAS402. Tony Crotty to send a copy of the aggregates plan to regulating officer.



Following the inspection a copy of the WRAP quality protocol was provided to NRW. This states that testing in line with British Standards for general fill is carried out at appropriate test frequencies. At a date agreed with the operator an audit of the aggregate WRAP quality protocol will be carried out in the new year.
