4. Details of our assessment

Forms S1, Emissions to Sewer, 1st January to 31st December 2021; E1, Energy Usage 2021; WU1, Water Usage 2021 and MR1, Mass Releases 2021, were received on 21st January 2022. Production was three times higher than in 2020. All the reports are accepted.

S1, Emissions to Sewer, 1st January to 31st December 2021

All emissions were within their respective emission limit values.

E1, Energy Usage 2021

Overall energy usage was more than in 2020 but was almost 50% less per unit of production. The electricity supplied to the Continental site comes from renewable sources. Continental have therefore not been able to provide an associated CO₂ production value. Some CO₂ will have been generated due to power losses in the transmission system.

R1, Waste Disposal and Recovery 2021

The total amount of waste sent for external treatment or to landfill was much more than in 2020. The majority of this waste was recycled. The total amount of waste generated per unit of production was about 10% less than in 2020 and the amount of filtercake produced was more than 25% less per unit of production.

WU1, Water Usage 2021

Total water use for the plating operation and associated processes was more than in 2020 but decreased by almost 35% per unit of production. This was largely achieved by modifying process cycle times.

MR1, Mass Releases 2021

Mass releases of cadmium and mercury were higher than in 2020, but both are well below the permitted concentrations. The releases per unit of production for both were less than in 2020.

This has been another difficult year for industries supplying the automotive industry due to Covid restrictions and various supply issues. Continental have implemented several resource efficiency measures and the reports submitted this year demonstrate that they have been effective. Natural Resources Wales hope that Continental may be able to identify and implement further opportunities in 2022 and that their business continues to grow.
