NRW officers Phil Harper and David Wilby visited David Neil, Helmydd, Trofarth, Abergele, Conwy, LL22 8BN on the 5th January 2022 at 10:45 am. Wayne Neil accompanied the inspection. The site is no longer operational.

The weather was dry and sunny.

The site is no longer operational, and work is in progress to clear the site with an intention to surrender the permit. Although no issues were observed within the permitted area, waste was observed outside the permit boundary. There are no conditions within the permit that state that waste activities will only take place within the permitted boundary. This matter will be dealt with separately to this compliance assessment report.
