4. Details of our assessment

Following an audit of Operator Self Monitoring (OSM) data submitted by the operator Dwr Cymru Cyf. (DCC), on the 27 September 2021, Natural Resources Wales (NRW) highlighted to DCC that iron data from January 2021 to July 2021 had not been submitted. The missing iron data was then submitted to NRW on 11 November 2021, however, permit condition OSM 9 in the OSM modification notice issued on 1st January 2010 requires that *"The analytical results from the monitoring programme required by condition OSM 1 must be supplied to the Agency in an electronic format defined by the Agency, as soon as is reasonably practical for each result, and at least on a quarterly basis."*

The iron data for Coslech STW was not received within the required timeframe, consequently a category 3 non-compliance has been recorded.

NRW's enforcement response in relation to this breach is subject to further investigation, however the operator is reminded that they must comply with this permit condition.
