Response to points raised in the schedule attached to Notice dated 19 June 2018 are included below together with all plans and documents described therein.

1. BG3 and BG11 Risk Assessment.

The amended risk assessment , now ref BG11a which contains additional details of Risk Management connected with activities. This document also refers to supporting information contained in BG4a, BG3 ( reference to the proximity of designated sites) and BG6 ( also referring to SSSI and SAC). Copies of BG3, BG4a and BG6 are enclosed.

The details of the SSSI and SAC " Citations" have been reviewed and the Risk Assessment is considered to take account of those details.

2 Resume.

In your earlier e-mail you refer to the Resume as a requirement for a "summary" which is the definition of Resume in the Oxford Dictionary, This is not a detailed description as if it was necessary, the requirement would surely have required a full detailed document.

My reason for including an undertaking to present the full ems on receipt of the Permit is that as well as including the full details of the proposal and its management it would also incorporate any additional matters included in the site permit.

The document BG6 also provides information on the site activities and their management in the required "Non Technical Summary"

Your request for "All Information" contradicts the titles " Resume" and "Summary".

a) Explains the CURRENT situation and has no relevance to the Proposed activities.

(b), (c) and (d) explains the proposed drainage arrangements.

( e ) You have already been advised that there are no existing impermeable areas and that none are proposed.

Plan BG1a shows the drainage ditches to which the surface water flows naturally and then into a series of silt traps prior to the settlement pond and then to overflow. This arrangement allows suspended solids to be retained in the silt traps and any remaining silt ( if any) to be held in the settlement pond.

All retained suspended solids will then be removed to the crushing and screening area for final treatment. All areas are hardstanding and any areas e.g on site vehicle routes will be consolidated for which the appropriate exemption ( U1) will be registered.

2. Continuing Competence.

The applicant confirms that the registration was his error and that he is now pursuing the correct award ( TMNH). This will be completed shortly.

In conclusion, I consider that the information contained above and provided previously meets the requirements contained in the application forms and have been accepted as such in previous applications when scrutinised by your colleagues.
