A review of the submitted 2014 and 2015 waste returns for permit number EPR-WP3694FZ has been completed and the following issues have been found:

c3) General management - materials acceptance. Permit condition 1.2.1, CCS score 4.

The waste returns indicated that the following non-permitted waste types have been accepted:

- In quarters 1, 2, 3 and 4 of 2014 and Q1 of 2015 you have reported taking in waste under LoW (list of waste) code 060405 (wastes containing other heavy metals);
- In Q4 of 2014 you have reported taking in waste under LoW 100915 (waste crack indicating agent containing hazardous substances);
- In Q4 of 2015 you have reported taking in waste under LoW 100916 (waste crack indicating agent other than those mentioned in 100915);
- In Q4 of 2015 you have reported taking in waste under LoW 160210 (discarded equipment containing or contaminated by PCBs other than those mentioned in 160209);
- In Q4 of 2014 you have reported taking in waste under LoW 180201 (sharps except 180202);

Please review waste acceptance and recording procedures to ensure that wastes are coded under the most appropriate list of waste code. If you wish to continue to accept these waste types you need to apply for a variation to your environmental permit.

Additionally:

Wastes accepted under exemptions should be recorded separately and not reported in the quarterly waste returns. Also, your S2 exemption is due to expire on 8 May 2016 and needs to be renewed with Natural Resources Wales before this date at www.naturalresources.wales/apply-for-a-permit/waste/waste-exemptions?lang=eng
