The inspection was carried out as a handover visit between the previous regulating officer (Rhys Ellis) and the new regulating officer (Steven White), and as a meeting to discuss the new AD plant at Lower Park Farm. The following observations about Lodge Farm AD plant were noted and brought to the attention of the site manager.

Officers discussed the new AD plant being constructed at Lower Park Farm and gave advice and guidance on which permit to apply for (SR2012 No10). The permitting process can take up to 3-4 months so as an interim measure it was suggested that the T24 exemption was registered on site until the application has been approved. The operator of Lower Park Farm AD plant would have to ensure that the limits set out in the exemption are adhered to; exceeding these limits (1250m³ of waste treated and stored) is an offence.

Officers were accompanied around the Lodge Farm plant by the site manager Tom Hodgkinson who showed officers round and explained the site operations. The site was in good order and was functioning in accordance with the permit. The pre-store unit was close to the top of its storage capacity with approximately 1 foot of freeboard left. This was brought to the attention of the site manager who assured that the height of the freeboard would be reduced as soon as possible.
