During the last inspection to site a number of non compliances were observed. These included:

- (i) mixed waste being deposited and stored outside the transfer building,
- (ii) the total amount of waste on site exceeded the specified 1100 tonnes,
- (iii) degradable waste stored inappropriately.

During this inspection it was observed that all mixed waste was being contained within the buildings on site in accordance with condition 1.1.3 of your working plan (version 4, January 2006). No degradable waste was observed being stored inappropriately

It was very difficult to determine how much waste was being stored on site (both non hazardous and inert), however with the mixed wastes, bales of rdf already on site and the stockpiles of inert waste the total quantity could quite easily exceed the 1100 tonne limit. You should therefore review the quantity of waste on site to ensure that you are complying with your current permit. As no further enquiries were made by myself on site regarding the total quantity of waste there will be no breach recorded on this occasion.

I observed quite a bit of loose waste litter within the yard area. Condition 4.6.1 of your working plan states that "light waste such as paper or plastic will be prevented from escaping from the site by being contained within the transfer building." You should try to ensure that the yard is kept clear of loose litter as much as possible. Should the site be in a similar condition during my next inspection a breach is likely to be recorded.

The presence of a couple of areas of standing water on the impermeable surface suggests that the drainage on site needs to be checked thoroughly to ensure there are no blockages. I was informed during the visit that part of the daily checks on site includes checking drainage. Whilst visual checks can be used to ensure the grids are clear they can't always be used to check the drainage system thoroughly. If this standing water is still an issue on site then you will need to arrange for the drains to be cleaned out.

Until your new permit has been issued you should continue to comply with your existing permit unless otherwise agreed.
