2014 & 2015 Waste Returns Review

A review of the waste returns for permit number EPR-YP3794EV has been completed. The following issues were identified:

- EWC code 130503 (interceptor sludges) was recorded on the Q1 2014 waste return in error.
- The quarter 2 2015 returns did not contain a description for EWC code 200121 (florescent tubes and other mercury containing waste).
- EWC code 200199 (other fractions) was miss-consigned in the quarter 3 2014, quarter 3 2015 and quarter 4 2015 returns. The amended returns have been resubmitted and the waste recorded under code EWC code 20 03 07 (bulky waste).
- A CCS category 4 breach has been recorded for the submission of incorrect waste returns.

Summary of breaches noted upon this review:

CAR sub criteria – G4 – Reporting and notification to Natural Resources Wales, Permit Condition 4.2.2, Compliance Classification Scheme Score Category 4.
