This was the first inspection following the issuing of a permit to Trojan Electronics Ltd (TEL) to operate under standard rules SR2008 No23 – Waste Electrical and Electronic Equipment authorised treatment facility (ATF) excluding ozone-depleting substances that was issued on 4 March 2015.

Matthew Jones gave an introduction into the operations carried out by Trojan Electronics Ltd during a site tour. A number of operations unrelated to the permitted activities covered under standard rules SR2008 No23 are carried out by TEL within the building based around distribution. The operations carried out under the standard rules permit SR2008 No 23 are carried out in a specific area that are limited to within the green lined area on the permit. TEL accept electrical equipment that has been classified as Waste Electrical and Electronic Equipment (WEEE) waste by the producer.

WEEE is received in the reception area and is accepted under a hazardous waste consignment note. Each pallet of WEEE is assigned a unique identifier specific to the producer and the type of WEEE contained within the pallet. The WEEE is then transferred into the area where assessment of each individual item of WEEE is undertaken. The assessment is carried out based on the reason for the return. The item will either be assigned as having no issues found and then repackaged. If there is a fault identified then TEL will attempt to undertake a repair and the equipment will then be deemed refurbished and go on for re-sale. If the WEEE cannot be repaired then it will be sent of site to a permitted site for processing. The WEEE is sent off as hazardous waste under a consignment note.

Following the site tour the written management system for the operations in relation to the permitted activities was viewed and inspected. The written management system contained the relevant information to satisfy condition 1.1.1 of standard rules SR2008 No23.

Consignment notes for the incoming WEEE (reference OAY565/14904) and outgoing WEEE (reference CAA064/88105) were checked and all aspects of the consignment note had been completed in full and correctly.

Phillip Rees confirmed that he will be acting as TEL's technically competent person and meets the requirements as specified in condition 1.1.4 of standard rules SR2008 No23.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) Order 2012.
