A routing site visit took place on Friday 17th March, 2017. Attending officers were Julie Hughes and Leon Williams.

Weather at time of visit overcast with some rain.

On arrival we found the gates to be open but no one in attendance. A walk around the site showed that skips were empty and very little road sweepings were being stored at the site.

A small container, near the gate, contained batteries. However the container did not have a lid which left the contents open to the elements and was full of water.

The above observations has resulted in the following breach bring recorded:

Table 3.2 states that the site shall be kept closed and secure at all times when unattended.

ACTION: ensure that staff training and EMS are updated to ensure that all staff are aware that the site needs to be secure when no one is in attendance. To be completed by 31st March, 2017.
