Broughshire site Inspection

I checked both the Broughshire TCM qualification and their Hazardous Waste registration and found that they are up to date. Furthermore Hazardous Waste Consignment notes were checked for Cars and Batteries and appeared fine.

I also checked your waste returns. However there was a minor issue in that they were recording their waste in tonnes and not as the required Kgs. **Please ensure that all waste is recorded in Kg and not in tonnes.**

Broughshire has recently passed their ISO 9001 and ISO 14001 audits in February 2016.

We discussed the fact that Catalytic Convertors are now considered Hazardous waste unless proven otherwise. Your permit does not currently allow separated Catalytic Convertors onto your site. The EWC code for these is 16 01 21. Please ensure that you add the waste code to your permit. The following link should be of assistance.
