**ENVIRONMENTAL PROTECTION ACT 1990 - SECTION 37
MODIFICATION OF WASTE MANAGEMENT LICENCE NUMBER S5**

On the 24th July 1998 the Agency wrote to you because your waste management licence allows you to receive wastes which were not special prior to 1st September 1996, but which may now be classed as Special under the Special Waste Regulations 1996. The purpose of the letter was to invite you to confirm to the Environment Agency whether or not you are receiving and wish to continue to receive these newly special wastes.

As you have specified that you do not wish to accept Special Waste as defined by the 1996 regulations, please find enclosed a notice under section 37 (a) of the Environment Protection Act 1990 for the modification to the above site licence.

Please note that this modification only addresses those conditions relating to the acceptance of Special Waste and does not modify any other conditions. Please note that this modification will not change the current operation of your site.
