**WHEREAS** on 22 March 1995 the Alyn & Deeside District Council granted to you a Waste Disposal Licence, now to be treated as a Waste Management Licence, Reference Number ~~198/95~~ relating to Spencer Industrial (North Wales) Ltd, Spencer Industrial Estate, Liverpool Road, Buckley, CH7 3EY subject to the conditions set out therein and in any subsequent Modifications.

**NOTICE is HEREBY GIVEN** that the Environment Agency ("the Agency") modifies the said conditions as follows:-

The following Conditions attached to Waste Management Licence Reference Number 198/95 shall be deleted,

Condition Number(s): D1, D3 and D4, and Appendix 3

and the attached Conditions, Waste Management Licence Reference Number 198/95 shall be substituted.

New Condition No: D1

D1.1 A record shall be kept of all wastes received and of all materials (wastes and recovered materials) removed from the site. The records shall include the following for each vehicle load of waste/material.

*for waste received*

- (a) origin of waste
- (b) date received
- (c) quantities in tonnes received and waste type as specified in Condition No: B1
- (d) nature of the waste (solid, liquid or sludge)

*for waste/material removed*

- (a) date removed
- (b) quantities in tonnes removed and waste and/or material type
- (c) destination of waste and/or materials removed
- (d) nature of the waste and/or materials (solid, liquid or sludge)

D1.2 A summary of the information, including nil returns shall be submitted to the Agency, in a format required by the Agency. Summaries shall be for each financial year and shall be submitted to the Agency within one month of the end of each financial year.

New Condition No. D3: Analysis of Samples

D3(a) A record shall be kept of all analyses undertaken in accordance with the requirements of Condition I3 of this licence. The record of each such analysis shall include a summary and interpretation of results.

New Condition No. D4: Inspection of Records

D4 All records required to be kept under Conditions D1 and D3 of this licence must be made available to any authorised representative of the Environment Agency for inspection at any reasonable time.

Such modification shall take effect on 31 March 1999 at 24.00 hours.
