The purpose of the visit was to assess compliance with permit reference EPR/MB3333DG.

Waste Storage

A tour of the site was undertaken and it was evident that improvements had been made. Additional skips had been arranged on site in order to further separate and organise ferrous and non-ferrous metals graded between light and heavy.

It has previously been agreed that the impermeable pavement on site should only be used to store spare/empty skips as there is no sump in place to serve it. ***Please continue to ensure that any ferrous and non-ferrous metal brought to site is deposited onto the hard standing only for sorting and not on the impermeable pavement.***

It was noted that some areas of the hard standing require a little maintenance. Pot holes were forming and filling with water. ***Please ensure the integrity of the hard standing is maintained.***

Environment Management System and Environmental Permit

A copy of the Environmental Permit and Environment Management System was readily available. The WAMITAB certificate held by Mark Tymkiv, the Technically Competent Manager for the site, expired in June 2017. An up to date certificate was provided confirming that the Continuing Competence Qualification had since been taken and was valid until June 2019.

Although there is still work to be done in order to further tidy the site, it was pleasing to see the continuing improvements being made.
