The purpose of the visit was to assess compliance with permit reference EPR/MB3333DG.

Jonathan Rees gave a short site tour of the operations carried out on site. Ferrous and non-ferrous metal is brought to site and then deposited on the hard standing area. The metal is then graded between light and heavy metal into separate skips. The area used to for the handling of scrap metal can be seen in the photographs below.



Impermeable pavement had been installed, yet no sump has been installed to serve the impermeable pavement as required under Table 2.3 – Operating Techniques of SR2011No2 and SR2011 No3. The impermeable pavement does not fully comply with the requirements of Table 2.3 as the impermeable pavement is currently not connected to a sealed drainage system, either a sealed sump or to public sewer.

This is a breach of condition 2.3.1 and has been scored a CCS 3 under B3 Infrastructure – site drainage engineering (clean and foul).

Jonathan Rees confirmed that it is the intention that the sump will be installed by 30 April 2016. Gareth Davies confirmed that if the sump is not installed by 30 April 2016, then Natural Resources Wales will look to serve a Regulation 36 Compliance Notice

At present Jonathan Mark Rees has not completed his WAMITAB training and there is no provision in place to employ someone to meet the requirements of condition 1.1.4. As there is no WAMITAB in place the operations are non-compliant with condition 1.1.4 of Standard rules SR2011No2 – metal recycling site.

This is a breach of condition 1.1.4 and has been scored a CCS 3 under C1 General Management – staff competency /training.

The above breaches also constitutes a breach of the written management system in that the written management system has

failed to identify and prevent a non-conformances of the environmental permit.

This is a breach of condition 1.1.1 and has been scored a CCS 3 under C2 General Management – Management system and operating procedures.

Discussions were held on the requirements of the waste returns. Trevor Davies intends to submit these on a quarterly basis.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
