The purpose of the visit was to discuss the current arrangements surrounding the Technically Competent Manager (TCM) at the site.

The site had previously employed the services of David Puckett to meet the requirements of Condition 1.1.4 of SR2011 No. 2 and SR2011 No. 3. Unfortunately, due to other work commitments, Mr. Puckett was no longer able to continue with this role and has now been replaced by Mark Tymkiv. The site is now compliant with Condition 1.1.4.

A tour of the site was undertaken and it was evident that improvements had been made. Ferrous and non-ferrous metal is brought to the site and deposited onto the hardstanding. The metal is then graded between light and heavy and placed into the skips which have been arranged on the hard standing.

During a previous visit, on 3rd May 2016, it was agreed that the impermeable pavement would only be used to store empty/spare skips as no sump was in place to serve it. During this inspection it was noted that one of the skips being stored on the impermeable pavement contained scrap metal.

**This is a breach of condition 2.3.1 and has been scored a CCS 3 under B3 Infrastructure - Site drainage engineering (clean and foul).**

Action - Please ensure that only empty/spare skips are stored on the impermeable pavement.
