4. Details of our assessment

A follow up site inspection subsequent to CAR_NRW0038675 was undertaken by Natural Resources Wales officer Ffion Quan. Officer on site was met by Vivian Williams, the owner/operator.

The weather throughout the visit was dry. The site was operational at the time of the visit.

Outstanding Actions from CAR_NRW0038675

- 1) All activities to take place on impermeable surface, within buildings.
- 2) ID board
- 3) Quarantine container
- 4) Drainage sump

All activities to take place on impermeable surface, within buildings

During our previous site inspection there was a significant pile of hardcore material on the external yard. As per permit condition 2.3.1, Schedule 1, Table S1.1, all activities will take place on an impermeable surface, within buildings. Subsequent to CAR_NRW0038675 you have now cleared most of the waste from the external yard.



As seen in the photograph above, there is some material left on the external yard. Included in your response letter to CAR_NRW0038675, you noted that the majority of the aggregate stockpile is recycled 'Type 1' aggregate, which is manufactured under the WRAP Protocol. As requested during the site inspection on the 13/01/2022, can you please forward all relevant documentation, including testing documentation and delivery documentation for every dispatch. Please can you also state what standard is the aggregate produced to by

the 11/02/2022.

ID Board

You had the requirement to place your updated ID Board near the entrance of the site. This action has been completed, as seen from the photograph below.



Quarantine container

During our previous site inspection in August 2021, an unpermitted waste type, tyres, was seen on the external yard. You were asked about the quarantine container, which was not placed in the location as noted in your management system. Subsequent to this, you have now placed the quarantine container in the correct location also easily identifiable with a sign. See photograph below.



Drainage sump

As noted in CAR_NRW0035227 and CAR_NRW0038675, the drainage sump within the main building as located on Plan VW/Drg/1 was inaccessible with no evidence that it is being checked daily in accordance with your working plan. During the recent inspection, it was observed that the waste surrounding the drainage sump has now been cleared, which enables you to check the sump daily in accordance with your working plan.

NRW are considerably pleased with the work that has been carried out at Viv Williams Skips following the site inspection in August 2021, we thank you for all your efforts and improvements.
