This was a pre-arranged meeting to discuss operational changes at the site in conjunction with a routine site inspection visit. NRW Environment Officers (EO) in attendance were Paul Challender and Andrew Sowerby and Flintshire County Council were represented by Danielle Richards and Ruth Cartwright. During the inspection the weather was warm, breezy and changeable.

At the time of the inspection operatives were actively sorting and baling waste. There were no issues regarding these operations; or the pre or post treatment storage of waste streams. Site infrastructure and security was in order and raised no concerns.

It was noted during the visit that there was plastic waste that had come away from the baled plastic which is stored at the rear of the site adjacent to the transfer building; behind the stored bales. This waste was limited to the immediate vicinity of the bales and had remained within the permitted area. You are reminded that this area should be checked and the free waste removed by the end of the working day and secured as per Section 5.3 of your Working Plan.

It was also noted that there was a small quantity of litter in the immediate area of the south eastern fence. This fencing did not have the secondary wind break/litter control fencing attached to the palisade fencing as in the other areas of site. This litter should be removed and during the forthcoming site alterations a suitable form of litter abatement should be effected along this fence line.

Danielle Richards and Ruth Cartwright appraised EO Sowerby and I of the proposed changes to operations in addition to proposed alterations and improvement to existing site infrastructure; along with queries regarding a variation to add additional waste code/s. Separate communication will follow regarding the specific the specific issues discussed.
