This CAR form is being produced following an incident on site on the 10 January 2017.

On 10 January 2017 we received a report (WIRS no 1700152) informing us of a fire on site at Brisco Waste Disposal Limited's Permitted site JP3995FK.

Following conversations with the site it was discovered that the woodchipper engine had caught fire, the fire had not spread to any waste on the site. Fire water on site was being contained and entering the sealed drainage system - entering the interceptor chamber. The outlet from the interceptor can be checked via a manhole cover close to the office at the front of the site. During the incident this was running clear.

Section 4.3 of your permit contains the actions required to be undertaken in the event of a fire. You have been assessed as compliant against this criteria.

According to the drainage plan from August 2015 the interceptor discharges to surface water, however Shaun O'Kelly was under the impression it went to foul drainage. During the next inspection it will be necessary to dye trace the outlet from the interceptor.
