Following notification that the site may have closed the decision was made to visit site to check.

Upon arrival at site it was observed that the gates were closed and there was a "closed" sign on the gate. There appeared to be no one around and when I looked over the gate into the site I observed that most of the cars had been cleared from site. I also observed a digger on site that looked as if it had been used to start clearing areas of the site.

As the gates were locked and no one seemed to be around I left site.

On the 26th October 2017 I phoned the site. When the phone was answered I was notified that the site was now being operated by McGills Car and Commercial. I was also notified on the phone that Frank Sherratt should be contacting me soon to keep me updated on the status of the site. I mentioned during the phone conversation that McGills and/or Frank Sherratt should contact me to arrange a site meeting to discuss future plans with regards the site activities and the permit.

I was also informed that the site may be operational again within the month but that it may not be operating in the same way as before.

Please keep me informed with regards the status of the site. Please also ensure that the site continues to submit waste returns even if no waste is being accepted or removed from site.
