The site inspection was undertaken to ensure the site was still non-operational. Initially the intention was to check the site through the closed gates which were secured with a sign saying it was closed. However, we happened to meet the permit holder Frank Sherratt on site and he showed us around and provided us with an update.

The site has been mostly emptied and apart from a small number of depolluted ELVs (approx. 5 or 6) there was no other waste on site. The site is currently being rented by Sean McGilloway of Flintshire Commercials/McGills Car and Commercial who has temporarily stored a few depolluted ELVs on site. He has been tidying up the yard with the intention of using it at some point in the future, though no dates are known yet.

I should ideally be notified at least 7 days prior to the commencement of any waste operations on site.

Waste Returns

These should continue to be submitted on a quarterly basis even though we are being told no waste is being accepted or removed from the site. We have received no waste returns for October to December 2017.

Please submit the missing waste returns, even if they are nil returns, by the 31st March 2018.

Following this, you should continue to submit waste returns as normal. No CCS breach has been applied for the missing returns on this occasion but one may be applied if they are not received by the specified date.
