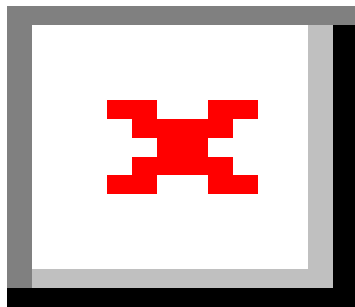

This was an unannounced inspection, regulating officer Steven White was accompanied around site by Gavin Butler and met with Darren Butler part way round the visit.

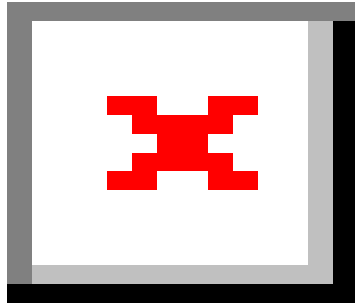
The new bays which had just been constructed in the previous inspection (28/02/2017) were in use and were working well; they were of sealed concrete construction and currently had various metals and some car parts in them.

The depollution area was checked, this was all under cover with batteries kept in the appropriate container (see photo below), waste oils were in bunded tanks and all this area would drain to the site interceptor.



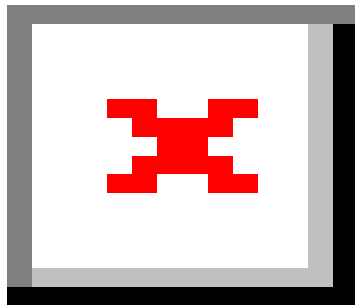
Battery box in depollution area

The waste fuel tanks are situated in a bunded area to the rear of the site office, this area is currently not covered and there was some rainwater observed within the bund (see photo below); when the interceptor is emptied you would need to empty this bund as well as there may be fuel contamination in the water. During the visit the renovation of the site office was discussed and the possibility of incorporating the covering of the bund with the proposed office renovations.

There was a pile of waste cans with some other contaminants (paper/food residue) from CA sites by the interceptor (see photo below), these had a large number of flies around them - Gavin stated that they would be removed off site within the next few days.



Darren Butler is currently undergoing the WAMITAB training for the site through Cambrian Training, Deeside; once Darren has passed the course can you forward the certificate to me so we can update our database.
