4. Details of our assessment

The ESH Targets Overview for 2021 was received on 26th January 2022.
The report is accepted.

The reduction in energy use was set at 2%. The actual reduction almost 20%.

There was also a target to reduce the amount of CO₂ generated from energy use. Continental purchase electricity from renewable sources, so this target relates to all the other energy used on site. The target was a 2% reduction, about 20% was achieved.

The target of reducing water use per 1000 parts was 2% and the actual saving was 4%. Some water is used in coolant and a project to reduce the amount of waste coolant is being started.

The waste generation reduction target was 2% per 1000 parts but it increased by about 30%. These results will be investigated to determine whether it is a real rise or a "one-off" and then to identify whether it relates to a particular waste stream.

The target for increasing the amount of recycled waste was 2%, the actual increase was about 3%. This metric has changed slightly compared with 2020 when it was to recycle 95%.

There was also a target to reduce the amount of waste soluble oil from coolant, which was 3%. The actual amount increased by more than 35%. This may be due to increased cleaning in Q3 and Q4 but there may be other underlying factors which will be investigated in 2022. A new machine has been purchased which has reduced coolant usage.

Compressed air use has been reduced by identifying and repairing leaks.

There has been a significant reduction in packaging travel miles and indirectly in CO₂ generation from transport. The target was 5%, 90% was achieved.

The focus of the EMS in 2021 was mainly on resource use and waste generation. Continental have been very successful in exceeding their targets for energy and water use. However, waste generation has increased significantly and so Continental have identified several areas for further investigation in 2022. This demonstrates best practice in the effective use of an EMS review to improve performance.

Natural Resources Wales are pleased to see the increase in production and hope that this recovery will continue into 2022.
