Harp International Ltd

Permit EPR/NP3099FS

Harp international's permit has been varied following the publication of the revised Best Available Techniques (BAT) Reference Documents (BREF) for Waste Treatment. The associated BAT conclusions to this document were published on 17 August 2018 in the Official Journal of the European Union. This variation incorporates the changes required by the Industrial Emissions Directive following a statutory review of permits in the Waste Treatment sector. These include the amendment of the wording of several permit conditions relating to notifications. As part of this variation Harp are required to submit responses to six improvement conditions by February 2022.

Annual Returns 2021

Harp international are required to report annually on their water, energy and total raw material usage for 2021. This information was received on the 13th January 2022.
