### 4. Details of our assessment

The Berwyn Hydro power scheme consists of two intakes on separate watercourses just upstream of the confluence. The intake on the Afon Clochnant is authorised by abstraction licence WA0670003020 and impoundment licence WA0670003021 and the intake on the Nant Cwm Tywyll is authorised by abstraction licence WA0670003022 and impoundment licence WA0670003023. The pipelines from both intakes join and take water to a single turbine house.

In August 2016, an inspection had identified that the intake structures and the pipelines were not built in accordance with the technical drawings in the applications. Compliance with the drawings was conditioned in the licences. At the time of the inspection, the manner of construction of the intakes, and the placement of the pipeline in the watercourse posed barriers to fish migration, hydromorphology and sediment transport in the rivers. In 2020, the operators applied to vary the licenses with new technical drawings for the structures that addressed the issues identified. The variations were issued in November 2020. Due to the Fisheries closed season for in-river works (15 May to 17 October) and the potential nesting season of Red kites in the area (March to August), the operators only had a short time window in September and October 2021 to complete the alterations.

We visited the site on 12 January 2022 in the presence of Mr. Owain Jones and can confirm that the hydropower scheme now matches the drawings and maps referred to in the current licences.

We specifically checked that:

- All pools under and next to the intake screens now have a minimum height of 300mm, making them safe for fish migrating downstream;
- The pipelines that had previously presented an obstruction within the river channels are now secured outside the channel as shown in the drawings and maps referred to in the licences;
- There are no gaps between the intake structures and the adjacent rock;
- The pipe dimensions match the drawings and are suitable to deliver the licensed flow regime; and
- The outfall is discharging through a grid mesh and is constructed in a way that minimizes potential erosion.

Due to the flow conditions, it was not possible to view the outfall and installation of the mesh properly. We therefore remind the operators to ensure that it is impossible for fish to enter the outfall pipe as per licence condition 9.7. The spacing of the grid should be no greater than 30mm and there should be no gaps that could enable fish passage (see condition 9.7.i of licence WA0670003020)

Overall, we were delighted to see how well the alterations had been made and how natural boulders had been incorporated into the layout, enabling geo- and hydromorphological variety in the river.
