### 4. Details of our assessment

The site has applied for a surrender of the permit but this hasn't been completed at this time. An inspection of the old permitted area was carried out on the 4th of May 2021. This was completed as a final inspection. I was happy that the asbestos storage container had been removed and everything has been decommissioned from the area. At this most recent visit the area had been decommissioned and is now a storage facility for the council depot. There is no evidence that the facility existed as shown in the photograph below:
