4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised to report on the review of the monitoring reports as per the permit requirements listed in Schedules 3(a) & 4(a) of the permit EPR/DP3735NP/V003. In addition, the submitted waste returns were also reviewed.

May I remind you that the reporting and monitoring requirements listed in your permit alter this year from 17th August 2022. From that date, monitoring should be conducted as detailed in Schedule 3(b) and reported as per Schedule 4(b). The new reporting forms as listed in Schedule 4(b), Table S4.4 are attached to this report.

Furthermore, Improvement Condition (IC) responses to address the BAT Conclusions of the Waste Treatment BREF Document (EU 2018) for ICs 1 - 7 found in Table S1.3 of your permit, are required to be submitted by Thursday 17th February 2022.

Waste Returns

Waste returns were received via email on 24th January 2022 in compliance with the timeframe required by permit condition 4.2.5. Q4 waste returns were received in addition to the Q3 returns which, had been resubmitted due to an omission identified by the operator. Thank you for the correction and resubmission. No issues were identified in the Q4 returns.

Annual Reporting

All 2021 reporting required to be submitted annually and by 31st January each year was submitted via email and received on 27th January 2022 in compliance with permit condition 4.2.2.

- An Annual Environmental Report believed by the reviewing officer to have been generated to satisfy permit condition 4.2.2(a) was submitted however, it's contents were light. The permit requires an interpretative review of the data.
 - **Action:** interpretation and review of gathered data should be conducted and submitted in the next annual report.
- Emissions to air were conducted as per permit condition 3.5.1 and reported as per permit condition 4.2.3. As identified in the Annual Environmental Report and in the Performance 1 form, the flare operated for <10% of a year and therefore monitoring was not required as per Note 2 of Schedule 3(a), Table S3.1.
- Annual Production/Treatment parameters were reported as per permit condition 4.2.2(b), Schedule 4(a), Table S4.2.
- Performance parameters were reported as required by permit condition 4.2.2(c), Schedule 4(a), Table S4.3.
