This CAR form accompanies the Air OMA, which focused on the monitoring of emissions to air (periodic and CEMs (Continuous Emission Monitoring Systems)) from the Stack Emission Release Points at Enfinium Ltd, Parc Adfer site carried out on 10/11/2021 by Berwyn Williams accompanied by Rob Hester and Rebecca Harwood.

The overall score reflects the operators well organised and robust approach to managing its monitoring activities. There are no findings or recommendations identified, instead the operator can focus on maintaining the high level demonstrated through the ongoing implementation and review of its management systems, procedures, and processes.
