2015 & 2016 Waste Return Review

A review of the waste returns for permit number EPR – NP3094FV has been completed. The following issues were identified with the Quarter 2, 2016 returns:

- 0.054 tonnes of EWC 160214 (discarded equipment other than those mentioned in 160209) have been described on the return as “non-hazardous electric motors”. Waste under this waste code is not permitted by the site’s environmental permit.
- 0.42 tonnes of an unlisted waste type had been recorded on the return.
- EWC 200301 (mixed municipal waste) has also been listed on the return without a quantity of waste. The waste has also been incorrectly described as “camping site waste”.

A CCS Category 4 breach has been recorded for the submission of incorrect waste returns.

NRW received an amended Quarter 2, 2016 waste return on the 27 September 2016 following a request to the operator.
