During the visit we were accompanied around the site by the Certificate Of Technical Competence (COTC) holder and Technically Competent Manager (TCM) Sonia Jenkins.

General Observations:

The site was very busy during the visit but good management practices were still evident. There was good segregation of waste types and waste storage areas were clearly defined.

It was noted that the new shed and picking line that handle the paper and card from Swansea Council was now online and fully operational.

There was litter around the site but this just reflected how busy the site was. There was no evidence that it was leaving the site and the TCM explained that a clean up happened at the end of every day.

TCM:

Sonia Jenkins is the COTC holder and has both TSNH and TMNH units of a WAMITAB qualification. The expiry date for the continuing competence certificate is 22/12/2017.

Hazardous waste:

The site does not receive any hazardous waste and is not registered as a hazardous waste producer. Advice was given that if a site does produce more than 500kg per annum (this would include waste oils from vehicle maintenance and interceptor waste etc.. then the site must register as a hazardous waste producer.

TFS:

The site was asked to provide information on TFS and if any wastes were sent directly or indirectly out of the UK. The site does export some waste types including; paper, card and textiles. This information was recorded on a separate form.
