Announced site inspection undertaken by David Ellar and Michael Edwards of Natural Resources Wales, accompanied on site by manager Sonia Jenkins.

During the inspection it was noted that there are good management practices in place on site with no signs of litter outside of the storage areas, and measures in place to keep small fragments of waste stored within the bays and within the sheds despite the adverse weather.

Infrastructure

The entirety of the site is made up of an impermeable pavement in line with **condition 2.1.2** of the Environmental Permit. During the inspection it was observed that the concrete was in good condition with no signs of cracks or deterioration. The sealed drainage on site was also in good condition with no pooling of water on site.

Storage of waste

During the inspection it was noted that all waste on site was stored within sheds, and within bays following physical treatment in line with **condition 2.1.1** of the environmental permit. No issues were identified with the waste types stored on site, with no indication of non permitted waste types being accepted onto site in line with **condition 1.2.1**. It was also confirmed during the inspection that the issues with waste returned raised in CAR NRW0026970 were clerical errors and have since been amended.

Staff Training

As discussed on site the expiry for the continuing competence certificate is 22/12/2017, please inform your site officer once the certification has been renewed.
