The site was inspected for the MRF activities alongside a permit compliance inspection completed by Mike Edwards which was detailed in a separate CAR form. Sonia Jenkins accompanied us around the site and Jen was present whilst inspecting the MRF activities.

Sampling:

Jen gave us a demonstration of how the MRF sampling was undertaken.

Sampling methodology was followed and scales were in calibration.

Several sampling input sheets were inspected and they appeared to be consistent with the waste input expected at the site. No irregularities were found.

Standard Deviation:

Whilst looking at sample output reports Sonia asked a query regarding the formula the used for Standard Deviations (SD) as they were using a slightly different formula on excel than previously advised. The SD were checked and they were found to be correct.

Waste Returns:

Waste returns for Q1 and Q2 were inspected and no issues were found. You had been previously advised not to round output figures up or down and to use one decimal place. This advice was followed and this years waste returns reflect this.

No issues or non-compliances were observed or recorded for the MRF activities.
