Routine site inspection conducted by Environment Officer Leon Williams accompanied by TCM Stuart Butterworth.

The inspection began in the site office where in date hazardous waste producer registration and WAMITAB certificates were inspected. Mr Butterworth explained that he only makes a note when he is away on leave from the site in the site diary. This arrangement had been agreed previously with Officer Andrew Sowerby. A number of waste transfer notes were inspected, no issues were found however Mr Butterworth explained that the SIC code for the business will be changed on the notes.


4 de-polluted ELV vehicles were present on site, this quantity is within the limits outlined in Section 1.5.4 of the sites EMS.

Mr Butterworth explained that it had also been agreed with NRW that pipe work associated with the sites' fuel tank can remain outside of the tank's bund as long as the stop taps are operational. The stop taps are located within the tank's bund. No evidence of oil contamination around the tank or the site generally, where observed.

No issues relating to dust, noise, odour, pests or deposits on the road leading out of the site, where noted during the inspection.

At the time of the inspection Mr Butterworth estimated that approximately 5000 tonnes of ferrous metal was present on site. A figure detailing the ferrous metal quantity prior to the current management taking over the site was not available. The actual quantity for ferrous metal on site is therefore unknown. Section 1.5.4 of the sites EMS states that all ferrous metal should only be stored on site for a period of 2 years. NRW do not currently believe that this condition is being complied with.
