During the site inspection I was accompanied by Regulating Officer James McClymont.

Upon arrival at site we were informed that the TCM Stuart Butterworth was not on site. He was at the Delyn Metals Point of Ayr site.

Stuart Butterworth is now semi-retired and he currently works on Tuesdays only. The main objective of this seems to be to ensure the TCM requirements under the permit are achieved until the site owner makes alternative arrangements.

During the site inspection we had a good luck around. A lot of the heavier metals from around the edges of the set has now been removed. The site is steadily being emptied, although it is still business as usual with waste still being accepted onto site.

If the intention is to empty the site and close it then you may want to surrender the permit. If this is the case please let me know any deadlines as soon as possible. The surrender process will take 3 months and that assumes all the correct paperwork is submitted. The site will need to be left in as good a condition as it was in prior to it being permitted. If you require any advice around the surrender process please let me know.

Overall there were no issues observed on site.
