This Compliance Assessment Report (CAR) form has been completed following a desk top audit of the site. A brief drive by inspection was also made and information gathered from the local NRM team. This lighter touch inspection has been undertaken in line with the SW risk prioritisation and due to current personal circumstances of the operator.

A data review for the site was undertaken this identified that the site has the relevant registrations required as a hazardous waste producer. This registration, CAC808, is currently due to expire 30<sup>th</sup> January 2018. If the operator is to continue to produce hazardous wastes they are advised to re-register.

Evidence below of current compliant hazardous waste producer registration:

The site has been submitting the required waste returns, to date the archive shows returns submitted up to July 2017. If any returns have not been forwarded you are reminded to do so.

A review of the returns confirmed that there has been a trend of waste removal from the site in comparison to acceptance.

Local watercourses were inspected on 18/1/18 and no signs of pollution identified.

The local NRM team were consulted and they confirmed that the site was not causing any concerns.

Email correspondence with the operator confirmed that operations had significantly reduced and the site was only open on a pre- appointment only basis.
