There was good segregation of waste types and they were all secured in accordance with the permit.

A hazardous waste consignment note for removal of waste oil from the site was inspected and everything was in order.

No non compliances or permit breaches were observed during the visit.

The only comment we would make and improvement we would like to see implemented is that the waste containers are better marked to indicate their contents e.g. waste oil, petrol, diesel. This would make quick identification of the contents of a container should an emergency situation arise.

The Certificate of Technical Competence holder (COTC) is Leeann Jones. Leeann holds an up-to-date 4MTELV6 WAMITAB qualification.
