### **Waste return review**

A review of the waste returns for permit number EPR-ZB3793HN has been completed. Condition 7.2.2 of your permit requires you to submit within one month of the end of each quarter the waste return for that quarter in the format specified in the form provided for the purpose. Unfortunately NRW have not received the waste returns for quarters 3 (Jul - Sept) & 4 (Oct - Dec) 2015 and quarters 1 (Jan - Mar), 2 (Apr - Jun), 3 (Jul - Sept), 4 (Oct - Dec) 2016. This is breach of condition of permit condition 7.2.2 of your permit and as a direct result of this breach a CCS score 4 has been applied.

You are required to submit all of the missing waste returns (quarters 3 [Jul - Sept] & 4 [Oct - Dec] 2015 and quarters 1 [Jan - Mar], 2 [Apr - Jun], 3 [Jul - Sept], 4 [Oct - Dec] 2016) to [waste.returns@cyfoethnaturiolcymru.gov.uk](mailto:waste.returns@cyfoethnaturiolcymru.gov.uk) no later than Friday 12th May 2017. A copy of the latest template has been enclosed for your use. You are also required to implement a management system by Friday 12th May 2017 to prevent this breach of permit condition 7.2.2 does not occur again in the future. Please could I ask you to ensure that the waste data enter on to form is in tonnes at all times.

Could I also remind you that the waste returns for quarter 1 (Jan - Mar) 2017 are due to be submitted to [waste.returns@cyfoethnaturiolcymru.gov.uk](mailto:waste.returns@cyfoethnaturiolcymru.gov.uk) no later than the 30th April 2017.
