Request by the regulating officer for this site, Steve White, that we check the site whilst in the area to see if there is any activity.

Environment Officers Andrew Sowerby and Paul Challender undertook a drive by of the site and noticed the gates to be open and that there was some activity on the site. As a result of this it was decided that a short inspection would be done to get an update with regards to the operational status of the site.

Mike Green not on site. However, officers did meet Craig Chadwick who informed us that he had now set up on site and started accepting and depolluting ELVs. He is operating under the name of City Metals (UK) Ltd. Said he had been on site since the beginning of the year. Currently he was managing the ELV side of operations on site and Mike Green was managing the waste metals. A quick walk around the site was undertaken. It was noticed that half the yard is now being used by another non-waste related company. This part of the site has been fenced off, though access is possible via a gateway. Depollution is now happening in half of the garage on the western boundary of the permitted area. The other half of this garage is in use by another business that repairs cars.

Photos were taken while on site. These showed a few potential issues such as a large puddle of water above one of the oil interceptors on site and some of the engines that had been removed from ELVS had been left uncovered. ELVs were not checked thoroughly to ensure they had been fully depolluted on site. A more detailed inspection will be undertaken by the site's regulating officer at a later date.
