A routine unannounced inspection took place on the 18th January, 2017.

Weather at time of visit was dry but there had been some light rain overnight.

Daily site inspection checklists were inspected which were found to be in order.

A walk around the tipping face was undertaken by the Regulating Officer and Moi. No issues were found during the visual inspection.

Whilst on site a Gwynedd Skips lorry arrived with a load for deposit, this was visually checked before being sent for deposit at the top of the site. The load was then checked, in the company of the regulating officer, and conformed to waste code 19 12 12 as described by the driver on arrival. This waste is being recorded on a season ticket. All waste deposited on site visually appeared acceptable. No issues.

Silt traps were inspected on a monthly basis and during periods of heavy rain and are emptied as required. Straw bales were also being used as a filter medium to stop silt from run-off entering the watercourse. Following discolouration of the watercourse in December additional straw bales had been placed on the bed of the watercourse with an additional stack of covered bales kept on site for emergencies.

During a previous visit it was found that waste had been deposited outside of the permitted area. This waste has now been removed as requested by the Regulating Officer. Thank you.

Works were being carried out on the slopes leading to the watercourse. Some of the waste material had found its way onto the bed of the watercourse. This will need to be removed immediately.

Quarterly data report was received in October 2016. These were checked and found to be in order with the requirements of the permit.

The site office may be relocated in the near future to an area nearer the site entrance, however no date

had been set for this move.

The above observations has resulted in the following breach being recorded:

Permit condition 3.3 .2 Fugitive emissions of substances – Category 3 breach has been recorded for:

Allowing the deposit of waste soils and stones within the watercourse which has the potential to cause pollution of the watercourse, specifically from silting should the waste material not be removed before rainfall.
