This was a routine unannounced site inspection carried out with fellow Environment Officer Leon Williams.

Weather conditions were dry and overcast whilst on site.

The site was operational with incoming waste being deposited before being profiled by bulldozers. The incoming waste was being inspected both when it arrived on site and when it was being tipped. The waste material being deposited at the site appeared visually acceptable, mainly consisting of brick and rubble at the time of the inspection.

Officers walked up and around the top of the landfill area - no recent operations appeared to have taken place here

No other issues were apparent whilst walking around the site.

Within the site office the daily site checklist was inspected. The document was fully up to date with all relevant fields completed. The document had also been completed for the days prior to the inspection.

No issues were noted relating to noise, dust, odour or litter at the site.
