A pre-arranged visit took place on 12th June 2018. Present were Julie Hughes Regulating Officer, Paul Wills TCM, Gerry Wills Operator, and Jane Bloor.

Considerable improvements had taken place on site since the previous site visit. All areas of the site are now accessible enabling sampling of all bore holes to take place.



Some work had taken place to clear the bed of the watercourse of inert material. This work will continue to ensure that there are no obstacles (including silt at the lower end) in the way to impede the flow of the river.



Ensure that old straw bales are removed and replaced.

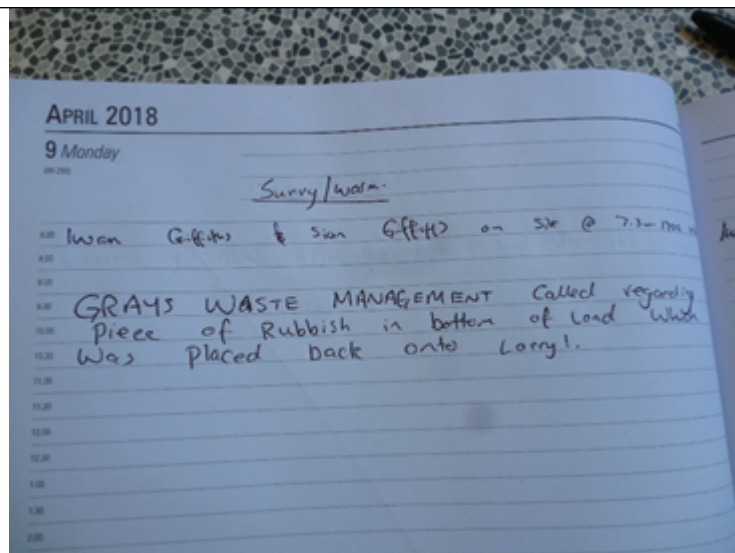


Quarantine skip was now being utilised for waste from site litter picks.



Site diary is now in use with records of staff attendance, rejected loads, litter picks etc being recorded

Visual inspections of waste arriving on site was been carried out, as well as at the point of deposit. Several loads had recently been rejected including contaminated waste from Gwynedd Skips and Grays waste.



Recorded Breaches

Unfortunately, the Environmental Management System (EMS) was not available for inspection. Paul Wills agreed that a copy would be kept in the site office for future inspection. The lack of EMS has resulted in a **CAT 3 breach being recorded against permit condition 1.1.1 (a) of category C2 Management System.**

Action: update EMS and submit a copy to NRW for review by 27th July, 2018
