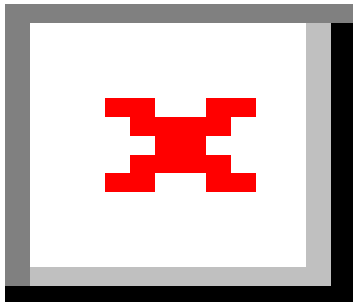

This was an unannounced inspection carried out by regulating officer Steven White and Environment Officer Madeleine Starks, David Williams was on site at the time of the visit.

There were a number of vehicles observed on site:

- 5 cars - one with coolant still in; this was brought to David's attention who said it would be removed straight away.
- 3 ambulances with engines removed
- 4 depolluted lorries
- The other vehicles on site were all HK Motors wagons

During the inspection it was brought to officers' attention that Henry Kingsley Williams had recently passed away. The named permit holder for the Minera site is only Mr HK Williams, if you wish to keep the permit ongoing at the Minera site then you will have to transfer the permit to new holders. Otherwise 6 months after the death of the sole permit-holder the permit will cease to exist and you will have to apply for a new permit in order to keep the operations going at Minera. Advice and guidance has been sent with details of how to apply for a permit transfer and charges for this to the company email address.
